Arbitrage - An Ideal Investment tool - In mature, efficient markets arbitrage happens quite rarely. But in nascent, less-mature markets, arbitrage occurs much more often.



Crypto Arbitrage - The crypto markets are immature and have in-built features that breed pricing arbitrage opportunities:

- Over 300 exchanges with well over a thousand tokens
- Non-stop 24/7 operation across all time zones

The Fund - The fund and all its management and governance elements are in place, forming a multi-regulated structure that is open for eligible investors who wish to participate in a segregated portfolio that derives its returns from the crypto arbitrage software and platform.

- The targeted annual return on capital deployed is 24% per year with returns paid out by the fund on monthly basis.
- Minimum capital required is UD\$100,000. Both crypto (USDC) and fiat can be paid in and received back.
- Capital is locked in the fund for 12 months (the capital can be withdrawn after 6 months with conditions)

- Fund operates for 12hours per day deploying the strategy across 67+ crypto exchanges and monitoring 15-20 coins.
- 80%+ of the trades the program identifies relate to Bitcoin whilst other transactions are exploited in single, triangular or quadrilateral patterns.
- Cautious management of the fund allows for 12hours downtime for reconciliations and closed positions.
- 60-80% of capital always held in USDC with balance exposed to trades for short period.
