# Immigration Policy



- ✦ In May 2017, the Turkish government launched the citizenship by investment scheme to introduce foreign investment.
- ✦ In September 2018, the Turkish government reduced the minimum investment amount from USD one million to USD 250,000, which has been made it one of the most attractive citizenship-by-investment programs.

- ❖ Over 18 years old
- ❖ Spouse and children below 18 years old can be included
- ❖ Investment amount: USD 250,000 to purchase one or more properties in Turkey
- ❖ Exit strategy: properties retained for 3 years
- ❖ Note : Additional fees is applicable towards KCG, Solicitors and Government fees.
